**PARTY WAIVER, PARENTAL WAIVER, RELEASE OF LIABILITY, INDEMNIFICATION AND
CONSENT FORM**

I, the undersigned, as the parent or legal guardian of _____ (my “**Child**”), do hereby give my full consent and approval for my Child to participate in the laser tag games and use the laser tag equipment and other activities provided or sponsored by The Game Guys, LLC (“**Game Guys**”) at the following address: _____ (the “**Location**”), which is owned or operated by _____ [insert name of party host] (the “**Host**”).

I fully understand and acknowledge that: (1) risks and dangers exist in my and/or my Child’s participation in laser tag activities and use of laser tag equipment and other activities provided, sponsored, supervised or assisted by Game Guys (the “**Services**”); (2) my and/or my Child’s participation in such activities and Services and/or use of such equipment may result in my or my Child’s injury or illness, including, but not limited to, bodily injury, disease, strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments or conditions that could cause death or serious disability; (3) these risks and dangers may be caused by my or my Child’s actions, and also from the actions, inaction or negligence of others, including the owners, agents, officers and employees of Game Guys; (4) there may be risks not known to me or not reasonably foreseeable; (5) the Host, and not Game Guys, are responsible for all activities and the Location; and (6) that by signing this Party Waiver, Parental Waiver, Release of Liability, Indemnification and Consent Form, I hereby authorize myself and/or my Child to participate in the laser tag activities and to use the equipment, and hereby assume all risks and dangers and all responsibility for any losses and or damages incurred or suffered by me or my Child, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers and employees of Game Guys, or by any other person.

I, on behalf of myself and my Child, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Game Guys and its owners, agents, officers and employees from any and all claims, actions, or losses for bodily injury, property damage, wrongful death, loss of service or otherwise which may arise out of or relate to my or my Child’s participation in the laser tag activities and/or use of the laser tag equipment provided by Game Guys.

I HAVE READ THE ABOVE, AND UNDERSTAND THAT BY SIGNING BELOW, I HAVE GIVEN UP SUBSTANTIAL RIGHTS ON BEHALF OF MYSELF AND MY CHILD.
